Direct that 3 month/s of the sentence imposed on charge(s) 1, 3 month/s of the sentence imposed on charge(s) 3, 3 month/s of the sentence imposed on charge(s) 5, 3 month/s of the sentence imposed on charge(s) 7, 14 day/s of the sentence imposed on summary charge(s) 9, 2 month/s of the sentence imposed on summary charge(s) 10, 1 month/s of the sentence imposed on summary charge(s) 15 be served concurrently upon each other and upon the sentence imposed upon charge(s) 6.

Direct that 1 month/s of the sentence imposed on charge(s) 2, 1 month/s of the sentence imposed on charge(s) 4, 1 month/s of the sentence imposed on charge(s) 8 be served cumulatively upon each other and upon the sentence imposed upon charge(s) 6.

Total Effective Sentence (State) is 3 year/s 3 month/s imprisonment.

Direct that the minimum term to be served before being eligible for parole is 1 year/s 8 month/s imprisonment.

Further declare the period that the prisoner has been in custody in respect of these offences namely 462 day/s, be reckoned as a period of imprisonment already served under this sentence, which is to be deducted administratively.

Summary Charge(s) 10
With conviction order that all Victorian licences and/or permits held by the offender be cancelled and that the offender be disqualified from obtaining any such licence or permit for a period of 12 month/s from 24/10/2019.

Charge(s) 6
